ne founder of Hopap Food Bank initiative, Mrs Tinuola Babafemi-Nakey, has said the organization is aimed at reducing hunger by establishing food bank in Delta

state Babafemi-Nakev who disclosed this in Asaba, said Hopap food bank initiative started in Canada, where she ran a successful food bank for the less privileged and later to Pakistan and South Africa

She added that she decided to come to Nigeria, her father's land to establish it, knowing fully well that the people needed it

She said, "It is a passion inside of me based on my past experience to provide good meals and groceries to some communities in the state.

"Nobody deserve to be hungry, and that is a way of giving back to the society because government alone can't do it.

The organization will set up a new initiative known as House of Praise and Prayer Food Bank Initiative to help support families with low income and struggling to eat.

"The initiative will help to provide meals and groceries for them on daily basis. On arrival from Canada, I started in Ibadan, Oyo state and will equally extend to other States in Nigeria.

"It will be established in the 25 Local Government Areas of Delta State and gradually move to other States"

She said her aim was to achieve zero hunger in the 32 States in Nigeria, saying that if she can successfully run food

bank in Canada, Pakistan and South Africa, that she would do better in Nigeria her father's land since she has been invited by some good Nigerians.

She said the initiative is open to good spirited individuals, corporate organizations that want to partner with the organization to better the lots of the less privileged.

INEC says over 400,000 PVCs lying uncollected in Delta

he Independent National Electoral Commission has disclosed that over 400,000 Permanent Voters Card (PVCs) are lying uncollected at the Delta state office.

Resident Electoral The Commissioner, Mr. Monday Tom made the disclosure on Wednesday while inaugurating the Executive and indeed members of the INEC Press Corps, Delta State in Asaba.

He said, "As you may be aware the Commission has stepped up its activities towards the conduct of the 2023 General Election, for which nine item, out of fourteen items has so far been attained in its time table and schedule of activities for the 2023 General Elections.

"Your induction into the Commission's value chain of stakeholder engagement matrix in Delta State, therefore testifies

to the commitment of the State Management of INEC here in the State to replicate what is happening at the national level, where an IPC already exists for over a decade to translate the gains of the robust relationship between the Commission and the media,

"It is significant to mention here that, your induction at the state level will benefit the media, particularly in understanding the language and nuances of political reporting and by extension activities of INEC, moreso now that, the Electoral Act 2022.is in place

"At the moment, Commission carried the over 244,715 uncollected PVCs from the 2019 general elections, while it has so far received about 69,946 PVCs, for those who registered between June December 2021 and 17,000

transfer PVCs, bringing the stock of PVCs held by the Commission, at the moment to well over 300,000 cards lying in the Commission's 25 LGA offices in the state.

"The Commission expects that, by the end of November, we will receive more PVCs, hence our desire to embark on aggressive mobilization of registrants to collect their PVCs, through the PVC Collection/Political Campaigns Sensitization, which has so far taken us to the State House of Assembly'

He stressed that the level of cooperation and understanding between the commission and media in Delta State will hopefully lead to better information management, particularly in reporting with responsibility and not pandering to the whims and caprices of unscrupulous politicians.

Illiteracy cured by education

The Pains of 2022 Flood

The 2022 flood as it has hitherto been referred to has wrecked havoc in many homes. It came with attendant difficulties and hardships. Many people have been rendered homeless, many families have been dismembered as the ravaging flood washed them away. The death toll cannot be estimated.

Most of the roads have been cut off thus subjecting road users and travellers to untold hardships. Stories were told of how an 18-seater bus fully loaded with passengers and private cars were washed away by the ravaging flood.

Many businesses have collapsed and many just managing to survive. Their business premises have been flooded and office machines, equipment, furnitures and so on have been swallowed by water. In some offices they cannot access their entry gate. The resultant effect is job loss. Yes many people have lost their jobs why some are reducing salaries. Who is to blame and who is to be blamed?

The animal kingdom on the other hand are not spared. Most of the wild animals in the bush have been consumed by the flood. Others like crocodile, snakes etc have found their ways to nearby bushes and construction sites in upland areas prompting hunters and fishermen to develop cold feat and phobia.

Farmers are counting their losses as well. Their crops such as cassava, yams, mellon, fish pond, poultry farm, goat, pig farms and so on are not spared. Some farmers were tempted to harvest their crops prematurely.

Everywhere you go the talk of the town is the flood. The flood took everyone by surprise. We all underestimated it. Nobody thought it would take this shape. In comparing it with that of 2012 most people reasoned that this year's flood superceded.

As an intervention, Delta State government has established Internally Displaced Persons, IDP camps in many of the affected local governments. In Ndokwa there are two camps; one at Ashaka and the other one at Utagba Ogbe. The effects of the flood would not be felt now.

The effects of the flood would not be felt now. There is going to be hunger in the land. Petty thief and pilfering would be rampant in the not too distant future. There is also going to be unwanted pregnancies.

NDOKWA VANGUARD is thanking Delta State government for rising to the occasion by establishing IDP camps and also to corporate organizations and spirited individuals that have sent relief materials to the camps. We are also calling on the state government to have a precautionary measures to cushion to effects of the hunger that would threaten in few months to come.

Flood ravages 19 LGAs, displaces thousands in Delta — Aniagwu

elta State Commissioner for Information, Mr Charles Aniagwu has said that ravaging flood has sacked thousands of residents in several communities in nineteen local government areas of the state

Aniagwu said that over sixty thousand Deltans have been displaced while goods and property worth billions of naira have been destroyed by the rampaging flood.

He stressed that the state

government through the State Bureau of Orientation had earlier alerted residents on low plain areas of the imminent flooding.

He added that Governor Ifeanyi Okowa immediately directed the setting up of camps and provision of food and relief materials to the flood victims.

He commended well meaning Deltans for their support to the flood victims and called for more assistance.

According to him, 19 out of

the 25 Local Government Areas of Delta state, have been largely submerged by water. That is not to say that the remaining 6 are entirely free but that those 6 are better off.

"We have been able to set up as much as 11 camps and we are still sending relief materials to individuals in some affected communities that are not in the camps.

"There are some communities that would not want to come to the camps because they see

Prof Achuenu expressed joy for the visit, adding that he was motivated by it and promised to change the face of polytechnic in his tenure. the

their communities as their ancestral homes. So we also try as much as possible to send relief materials to them even when they are not in camps.

"We are hoping that the members of these communities, individuals and the private sector would try and see how they can come to the aid of these persons in camp.

The state government is doing a lot and what has helped us so far to mitigate casualties, is that we started our sensitisation on time. The state Bureau of Orientation has been very busy in the last three months, making it known to the people that this flood would come.

"So that has helped some persons move away from flood prone areas before the flooding; otherwise, it would have been worst than what it is now.

"We do hope that as we make progress. the Federal government just like the Governor said, in the course of his visit, should come to take steps to address this issue of flood, by seeing how the rivers Niger and Benue can be dredaed.

"There is also the need to establish dams to help contain some of these waters whenever it is released, so that we do not continue to go through this perennial crisis of flooding of different communities." he said.

On the total number of persons displaced by the flood, Aniagwu said it was difficult to estimate the figure because majority of the victims were not in camps.

"You can't easily put a number to those affected, because of communal spirit, some of them have moved to stay with their relations.

"In the camp we have over 20,000 persons as at few days' ago. The challenge is that more persons keep moving in on daily basis because the flood is yet to recede, you have more number of persons trooping to the camps so the number has gone beyond 26,000 at the moment.

"Displaced persons is over 60,000, their farmlands have also been submerged and the State Government has continued to provide electricity and other facilities in the camps to make them at least comfortable.

The Governor transversed these areas even when it was raining to see a number of our people who have been displaced on account of the very disturbing flood."

professionals so as to discourage their migration from the country in search of greener pastures. Every visionary government must take proactive steps aimed at providing qualitative and affordable healthcare delivery system that will take care of the vulnerable segment of the society. "I am glad that you have a strong commitee, especially in the current times that we are in with lots of issues in our nation. I believe that your work is not easy and you

The Federal Government had through the Minister of Sports and Youth Development, Sunday Dare instructed the NFF to amend the Statutes by enlarging the elective congress before embarking on the electoral process, a directive that was violated by the then Amaju Pinnick-led NFF Board.

NDYCN Urges Buhari to Inaugurate NDDC Board confirmed by Senate Since 2019

The Niger Delta Youth Council of Nigeria (NDYCN) has called on President Muhammadu Buhari to inaugurate the substantive board members led by Dr Pius Odubu as Chairman and Chief Bernard Okumagba as Managing Director for the Niger Delta Development Commission NDDC screened and confirmed by the National Assembly since 2019.

"We have been patient for a very long time thinking that President Buhari will in the interest of the people of the Niger Delta Region inaugurate the Dr Pius Odubu and Chief Bernard Okumagba-led NDDC board, which was duly screened and confirmed by the National Assembly. Sadly, up till now it has been one ad-hoc arrangement or the other, which is against the Act Establishing the CommissionI.

"We are approaching another election next year; what is the President and the APC going to tell our people in the Niger Delta Region? That NDDC could not perform because there is no substantive board? As we speak, a lot of persons are angry and disappointed that Mr President is yet to inaugurate the NDDC board which was duly screened and confirmed by the National Assembly since October 2019." Omoniyi, while commending President Buhari over Thursday's approvals for the disengagement of the Effiong Okon Akwa-led interim Administration of the NDDC, however cautioned against the re-constitution of a new interim management Team and Governing Board of the NDDC.



Sam Mariere: Making Good water Available to Deltans

One major cause of diseases and sicknesses in the developing and portable water for use by the people. There is water everywhere particularly in southern Nigeria yet there is no good water, good enough for human consumption in many Nigerian homes. Most people fall sick because of the bad water they drink and use for domestic purposes. Many lives are lost annually to water-borne diseases arising from unmitigated poor access to safe drinking water.

Statistics show that 36% of urban dwellers and 61% of rural dwellers are totally unserved safe water. Protected dug wells are available to only 7% of urban dwellers, while 17% of rural dwellers have access to it. Borehole water pumps are available to 11% of urban dwellers and 7% of rural inhabitants. Yet a great percentage of boreholes or pipeborne water as personal initiative of individuals cannot guarantee good or clean enough water in homes. Some people drink 'poison' in the name of pipe-borne water because many of those facilities pump water with so many impurities that are not visible to the eyes.


People fall ill every day, contracting malaria, dysentery, cholera, typhoid fever and other related diseases which account for most of the cases in our hospitals because of the lack of good and well treated water they take in their homes. Many people in the riverine area of the southern belt live on top of water yet have no access to good water. Quite often, you see people swimming in the river while water is being fetched from the same river on the other side. In some cases, water for use in homes is collected from the river with a lump of human excreta floating on top of the river. The bucket is used to roll away the floating excreta before the water is collected and the water will not be treated or boiled before being drunk by the household. This is one of the many ways diseases are contracted by the people who are surrounded by water or practically live on top of water in riverine (rural) communities.

communities. The sources of most water we take as sachet and bottled water are also questionable. Many of the water we take with pride are packaged in an unhygienic environment with the possibility of spreading diseases. Many people have borehole water in their homes yet still resort to sachet and bottled water for drinking purposes because of the strong conviction that the water in their homes is not safe enough for drinking. The curious aspect of the saga is that they will not mind the state of the so-called pure water (sachet water) they take so long as they are not aware of the sources.

not aware of the sources. Statistics has shown that there are approximately 4 billion annual cases of diarrhoea, causing 2.2 million deaths mostly among under-5 children (equivalent to a child dying every 15 seconds). Intestinal worms infect about 10 % of the population of the developing world. These intestinal infections can lead to malnutrition, anaemia and retarded growth, depending on the severity of the infection. About 6 million people are blind from trachoma and at least 500 million are at risk of this disease. Adequate quantities of water reduce the median infection by 25 %. Approximately 200 million are infected with schistosomiasis, of whom 20 million suffer severe consequences.

20 million suffer severe consequences. Well-designed water and sanitation interventions reduce the median infection by 77%. Arsenic in drinking water is a worldwide problem that can be prevented by ensuring that everyone has access to safe drinking water, adequate excreta disposal systems and good hygiene behaviours. Adequate quantities of safe water and good sanitation facilities are necessary conditions for healthy living.

The Delta State Government, over the years had sunk so much funds in the water sector in order to make safe drinking water available to the people. However the impact has been negligible. Provision of water for



the citizens is big business in the developing world. It is the government responsibility to ensure the citizens have access to safe and well treated drinking water. People drink water every day. Water is the best drink anybody can take, better than the choicest wine in a grocery store. Water is life yet cheap. Water is a basic nutrient of the human body and critical to human life. It supports the digestion of food, absorption, transportation and use of nutrients and the elimination of toxins and wastes from the body. Water is also essential for the preparation of food stuffs. The sources and handling of water from the source to end users are the issues of grave concern to

transportation and use of nutrients and the elimination of toxins and wastes from the body. Water is also essential for the preparation of food stuffs. The sources and handling of water from the source to end users are the issues of grave concern to responsible governments the world over. The Ministry of Water Resources Development, together with her development partners including the World Bank, the European Union, WHO, UNICEF and other global organizations have demonstrated appreciable concern for the water and hygiene demands of the people in Nigeria and other nations of the world. Multi-national companies like SPDC, Chevron etc, operating in the country are not left out, intervening in many critical aspect of the water and environmental safety of the people. Evidence of their intervention are everywhere in Delta state yet, the role of the Ministry of Water Resources remain unsung.

On resumption of duties, Hon Chief S a m u e l Oghenevwogaga Mariere, Honourable Commissioner for Water Resources Development, Delta State demonstrated un precedent to doggedness in the pursuit of the state government goals of making safe drinking water available to the people. His first step was to hold crucial meetings with critical staff of the various

agencies and corporations in the ministry to get first hand information on the prospect and challenges in government efforts at making water available to the people. His major concern is to return Delta State to those glorious years of the past when "water board" was pumping safe and well treated water to streets of major towns in the then Bendel State.



With the level of work done so far covering about 95% of the project component, there were assurances from the company that when completed in a matter of months, the project will ensure public water is delivered to about 3,000 homes in Warri by January 2023 as first phase of the project while at completion in a year's time, it would serve about 22,000 households in Warri and environs. As at the time of writing, Hon Sam Mariere had succeeded in getting the State Exco approval for the guarantee needed for the company to drive the Warri water project in the needed direction. The places visited include the Ogwashi-Uku water Dam built by the Federal Government with plans to secure the release of the dam to the state government, different water schemes at Orogun, Agbarha, Ogor, Ughelli Towns in Ughelli North LGA and some towns in Ughell North LGA and some towns in Ughell North LGA and some towns and Rural Water Corporation, Small Town and Rural Water and Sanitation Agencies are all being galvanized to up their game with plans in place to design a Public Private Partnership to manage the different major water schemes in the state towards better service delivery.

major water schemes in the state towards better service delivery. Hon Mariere's determined approach sure signposts a watershed in managing the water delivery efforts of the state government. He is leaving no stone unturned in pursuing the state government's dream of improving access to potable water in Delta State including protection of water sources, control of water treatment processes and management of distribution and handling, analytical monitoring of water quality, and periodic impact assessment of portability level of water consumed in communities across the state, with many having miscellaneous sources of domestic water supply.

The message is clear. It can never be business as usual. Hon Sam Mariere is determined to effect changes in the water and sanitation drive of the state government. His target is to get the Don Domigo Water Scheme in Warri functional before the end of this administration. He is also determined to ensure some critical water schemes in designated Local Government Areas take off under his watch. Ughelli, Warri and Agbor are receiving critical attention. Many schools and communities are surely going to get water and toilet facilities in the next few months. His battle cry is that he cannot be in the Ministry of Water Resources without evidence of having provided water for some areas where water had not been available. TINUBU: FROM DECEPTION, FRUSTRATION TO CONFUSION

he feelers from the Asiwaju Bola Ahmed Tinubu camp indicate that all is not well in his camp now what with ■ is not well in his camp now what with the concatenations of many events that has taken place since his controversial emergence as the All Progressives Congress (APC) presidential candidate and his many gaffes that seem to question his state of health and mind. The erstwhile Lagos State governor has declared his intention to contest for the highest office in the land apparently on the grounds of false sense of entitlement highest office in the land apparently on the grounds of false sense of entitlement (emi lokan—it is my turn), the help of the power of incumbency and the dominance of the press and media propaganda as heretofore but the APC's woeful performance in the last seven years, the declaration by Mr. Buhari, the incumbent precident to conduct from and foir election president to conduct free and fair election, the inability of his media group to contain the inability of his media group to contain the amorphous social media tsunami, the Tinubu's deteriorating health condition that his team has tried unsuccessfully to conceal from the public knowledge, the result of the Osun State gubernatorial election and many other issues that will be highlighted in this piece seem to confront them frontally putting his camp in a state of quandary. And Mr. Festus Keyamo, the erstwhile "social activist and advocate" the current Minister of State for labor under whom the country has witnessed the longest industrial action by the university lecturers and the Tinubu campaign spokesperson is having a herculean task playing the devil's advocate, defending the indefensible. Evidently, what is happening in the

Tinubu camp now is outright confusion. The campaign for the 2023 presidential election has started officially since 28th of September and Tinubu is nowhere to be found. He is yet to inaugurate his presidential campaign council and he was visibility absent during the signing of the peace accord by the presidential candidates of the parties. And there was no official explanation for his absence fueling the speculation that he was smuggled out of the country for medical treatment. And in another futile bid to explain the state of affairs concerning him, his campaign organization released a video of Mr. Tinubu purportedly riding on a treadmill in a gym in UK. But the opposition said it was an attempt to opposition said it was an attempt to mislead and hoodwink members of the public since the said video was something that was aired 9 years ago when Tinubu was recuperating from knee surgery in the US. And concerned observers have asked that even if the videos were recent events as claimed by his team, why would Tinubu indulge in the folly of traveling to UK to ride on a treadmill just to prove that he is healthy while he just to prove that he is healthy while he has importance functions to attend to at home? Is it not a misplaced priority? If he is elected Nigerian president, would he not do the same: fritter away time and resources indulging in frivolities while important state duties suffer?

Clearly, the concatenation of events since his emergence depicts desperation, deception, frustration and everything is snowballing into total confusion. Shortly, before his emergence as the party's flag bearer he had blatantly declared to the consternation of Nigerians that it was his turn to be the president of the country and that he was ready to fight dirty to achieve his vaulting ambition. Also,

he declared that if elected, he would sustain Mr. Buhari's policies apparently indicating that he has no programs other his selfish ambition to be president. In a desperate bid to cajole and woo the Moslem North, he chose as his running a fellow Moslem, something that elicited much

unsavory reaction and debate more so as Kashim Shettima whom he picked was a notorious Bokoharam apologist. Again, in a vain attempt to play down on this obvious a vain attempt to play down on this downed blunder, his team was insinuated to have hired unknown and fake Christian clerics to grace the occasion of the unveiling of Shettima at the Yar'Adua Center, Abuja on

the 20th of July, 2022. Evidently, in the near-absence of any major thing to campaign with, the Tinubu's team has relied precariously on propaganda, false claims and wrong attributions and these have boomeranged. The use of social media influencers, engagement of media hirelings and hack-writers and the alleged sponsorship of false allegation against the major political opponent—Atiku and Obi—have also failed because the Obi—have also failed pecause me amorphous social media space is out of their control. The team is battling to explain the issues surrounding Tinubu's many scandals, his shadowy origin and poor performance while in office as governor of

Lagos State. The footless narrative by T i n u b u supporters about Tinubu

building and transforming Lagos was ruptured by

the Nigerian public that proved assertively that Lagos is the creation of the colonial government, the Federal government as well as enterprising individuals and that no one individual and no governor can claim to have built Lagos singlehanded and that of all the governors that Lagos has produced, Tinubu's contribution seems to be the most insignificant. Again, the hypothesis about Tinubu developing people was also torn to shreds by concern Nigerians who pointed out that giving political appointments which is a appointments which is a constitutional requirement of public office holders is not akin to developing people and that appointing people to advance one's political interest is not equivalent to developing people. Moreover, available records show that Tinubu build no schools, no skills acquisition centers or had any man power development program for the area boys of Lagos during his tenure. By the time he left Lagos, it was still ranked as educationally disadvantaged state with hordes of area-boys and street urchins everywhere. So, whither is his human development credential? Added to this is the fact that under him, there was the establishment of agencies that made life unbearable for the people and the preferment of area-boys. And preferment of area-boys. And extortion, touting and swindling became a bourgeoning business. Perhaps the most difficult matter

confronting Tinubu's camp was how to handle his health status. The few public appearances that he had made after his emergence as the APC standard bearer were a total disaster and that probably informed the decision by his team to bar him from interviews and public appearances. There are video

footages of his trembling hands, wobbly footstep, incoherent voice, slurred and uncoordinated speeches. At the Emir of Gombe Palace where he had gone on a courtesy call, he was videoed dozing off while in a meeting. In the mosque he has been spotted sitting on a chair during Jumat services; something that is allowed only for the very old and very sick. And that explains why he could not attend the NBA and the LCCI conferences attended by the presidential candidates



of the other political parties even when the conferences were held in Lagos where he resides. They were also said to be unsettled by the Pirates' Emi Lokan

song that satirized Tinubu's health condition.

Other signs of desperation by Tinubu and his team include his romance with the Nvesom Wike the River State governor and PDP stalwart his visit to Jonathan whom he had described in 2015 as a clueless president. It was like the MKO Abiola eating the humble pie by visiting Chief Francis Arthur Nzeribe whom he had thoughtlessly scoffed and told that he can do without him and his people earlier, after his return from the US. The likes of Tinubu may appear smart but they are myopic and dyslexic in their thoughts and conducts. They think of now and now without consideration for the future. They are blinded by fleeting considerations, greed and inordinate ambition. Tinubu's visit to Jonathan whom he once despised, vilified and demonized portrays Tinubu as an inconsistent, hypocritical and a desperate power monger. Furthermore, obvious signs of

frustration can be seen in the utterances and behaviors of members of his team and button boys in search of scapegoats for the imminent failure. The area-boys of Lagos have been placed in overdrive mode and they harassing and extorting Ndigbo in Lagos. There are reported cases of the extortion of the Lagos State Keke operators by the imposition of Tinubu/Shettima stickers and the planned closure of Oyingbo and Ladipo markets on flimsy excuses by the Lagos State government all in an ill-conceived attempt to muzzle the people. Tinibu's daughter

Folashade Tinubu-Ojo was reported in the media to have insulted the Igbo calling them ingrates and she was also reported to have perforce dragged all the market women in Lagos to a rally in honor of her ailing father. Tinubu's wife Oluremi who is supposed to be a senator was captured in a video threatening to expel the Igbo from Lagos if her husband loses the presidential election. Added to this is the report that there is ban on advert signage for Obi and Atiku in Lagos. No doubt, these are luminous signs of frustration and politics of bitterness and rancor.

But Tinubu and his acolytes in Lagos have short themselves in the foot by their continued threat to force Ndigbo out of Lagos if Tinubu fails to achieve his vaulting ambition. His hatred for Ndigbo and his resort to ethnic demagoguery will be his ultimate undoing. As it stands now, the only way out of the thrall of area boys in Lagos is to vote against Tinubu otherwise the area-boys will be more emboldened to unleash mayhem on others in the unfortunate event of Tinubu's victory. The APC has no consideration for us neither does it take responsibility for its actions therefore in this circumstance it is only one without scruples or low self-esteem that will support Tinubu and APC.

The truth is that the failure of his guiles and political artifice and the looming reality of failure seem to have exacerbated Tinubu's fragile health. He had banked seriously on official manipulation and electoral malfeasance but when that failed in Osun and the declaration of Mr. Buhari to conduct free and fair election and the towering presence of Atiku Abubakar in the North against his sponsored campaign for an all-out southern candidates and the unexpected emergence of the enigmatic Peter Obi who would grab a huge swathe of the votes from the South, frustration and despair set in. And

instead of telling the people the truth the campaign team is pushing poppycock tale of the APC presidential out the APC presidential c a n d i d a t e gallivanting in Europe while the inauguration of

his presidential c a m p a i g n council is postponed indefinitely because of his glaring absence. This is pure deceit. And the implication of this is that if they cannot come out clean to tell Nigerians the true state of affairs concerning Tinubu, it means that if Nigerians are unfortunate to elect him, they will not be transparent and would not be accountable to the people. Honesty and integrity are adjunct to the qualities of a leader. However, one thing is clear now Tinubu

camp media dominance is broken. Nigerian will not be deceived by media propaganda and fake political activism and advocacy by charlatans and maly-mouthed political pettifoggers pretending to be working for the masses as heretofore. The yoke of hypocritical siege is broken for good.

At this critical phase of our checkered political history, Nigeria needs a leader with character/integrity, competence (mental and physical) and capacity (the patriotic zeal, the willingness and the drive) to work for the unity and progress of the country. Nigeria will not vote for the dotard who would fritter our time on when vital state meetings are going on, who would wear diaper, catheter and probably carry potty-chair about for eventuality.

I have reiterated it for the umpteenth time hat the adoption of Tinubu by the APC hierarchy is an affront on Nigerians for it implies that the party wants to sustain the status quo and so voting against Tinubu and his party will be the condign reward for their deception and treachery. Tinubu should withdraw from the race immediately and apologize for attempted political fraud or face disgrace at the polls. Indeed, Nigeria must break free from this vicious circle of making electoral mistakes and regretting later.
